Hilton Brett has served as a Non-Executive Director on the Guzman y Gomez Board for over five years and brings a wealth of experience and expertise to the leadership team, with an impressive track record in the business world spanning more than 25 years. Notably, he has held the position of co-CEO of Accent Group Limited, a \$1b ASX-listed company, where he led the company in delivering total shareholder returns of over 25% CAGR.

With a proven ability to drive operational excellence, expand market presence and navigate the complexities of being a public company, Hilton is uniquely qualified to help Steven lead GYG through its next growth phase, including its expansion further into the US market and IPO preparations. Hilton has public market CEO experience, he's scaled businesses and he knows finance, real estate, operations, procurement, legal and HR.

Hilton has also shared the role of co-CEO in the past and therefore knows what it takes to succeed. We trust one another implicitly which is important in any working relationship but particularly one like ours where we'll be working so closely.

Hilton is an outstanding executive and co-CEO and I know our franchisees, leadership team, Hola Central teams and investors will join me in officially welcoming Hilton to the role."

Under Steven's leadership, GYG has achieved remarkable success, most recently reporting a 32 percent lift in global network sales to \$759 million in FY23, while also earning a reputation for its exceptional food quality and outstanding customer service. The addition of Hilton as co-CEO is expected to bring even further capabilities to help drive growth and innovation within the organisation, while also preparing the company for a successful listing on the ASX.



Hilton Brett stated,

"It had to be a really special and unique opportunity to get me to become a CEO again, and, in my opinion, GYG is one of the best consumer businesses in the world. GYG's restaurant economics are some of the best in the world and we have at least 800 more restaurants to roll out in Australia alone which gives us an unbelievable growth runway for many years to come. The opportunity to be part of this was too good to say no to.

GYG really are reinventing fast food. The quality of our food, the incredible guest experience, the white space here in Australia and globally and the unit economics of the restaurants are second to none.

There are very few people that have achieved what Steven has. I am inspired by his passion and vision and having the opportunity to work alongside him to build GYG into one of the best restaurant businesses in the world is a privilege.

I feel what I bring to this partnership is public market CEO experience, 25 years of running retail businesses, experience in growth and scaling the business and knowing what's required to put in the support and infrastructure to be able to execute our strategy."

The last five years saw Hilton Brett serve as an Operating Partner at TDM Growth Partners (TDM), GYG's largest shareholder. With this new appointment, Hilton will be leaving TDM to focus full time on GYG.
